Lincoln, Cindi v. Hovind, Kent

My Defense against Cindi's PFA violation accusation.

My ex-wife Cindi Lincoln has falsely accused me of violating the PFA on July 10, 2022. Here are the facts. I did not violate the PFA. This PFA is related to the bigger case where she falsely claims I "body slammed her." This case is yet to be heard by the court.

I've been a Christian for over 53 yrs. and an ordained Baptist preacher for 48 years. I began the Creation Science Evangelism (CSE) ministry in 1989 in Pensacola, FL. In 2016 we moved to Lenox, AL.

Cindi Lincoln came to work at our church ministry in about 2017. A year later we were married and remained happily married for about 3 years. In the 3 years we were married I never hit her, harmed her, raised my voice at her or threatened her in any way. She, however, has often been violent and many of our church camp staff think she shows signs of being bi-polar and will testify to this if need be.

On about Oct. 26, 2020 as I walked out of our bedroom to go to work she began an argument and then violently attacking me in our kitchen as I tried to calm her down and escape out the north door. I had been told by the lawyer on our church ministry board, Atty. Alex Stephano, 305-450-8550, and by our ministry board to record any time she became angry or began cursing, or threatening to me, both for my protection and the protection of our church ministry. I recorded the entire confrontation, about 10 minutes, and told her I was recording as I had been instructed to do by my attorney. I had nearly broken my left arm in a construction accident a few weeks earlier and I was holding my phone over my head in my right hand as I tried to back out the door to escape when she suddenly lunged at me to get the phone so she could, as she said, "Give me that G...D... phone so I can break it in half and flush it down the toilet!"

I was simply defending myself and my property as I pushed her to the side and she hit the shelf then fell to the floor screaming and cursing. I immediately bent down to help her up and asked her what she was doing.

Some months after this event she moved to her house on Hwy 41 (Ex. 3) and, after my (and others) repeated attempts to reconcile the marriage that failed, the ministry board recommended we file an annulment to the marriage, which we did.

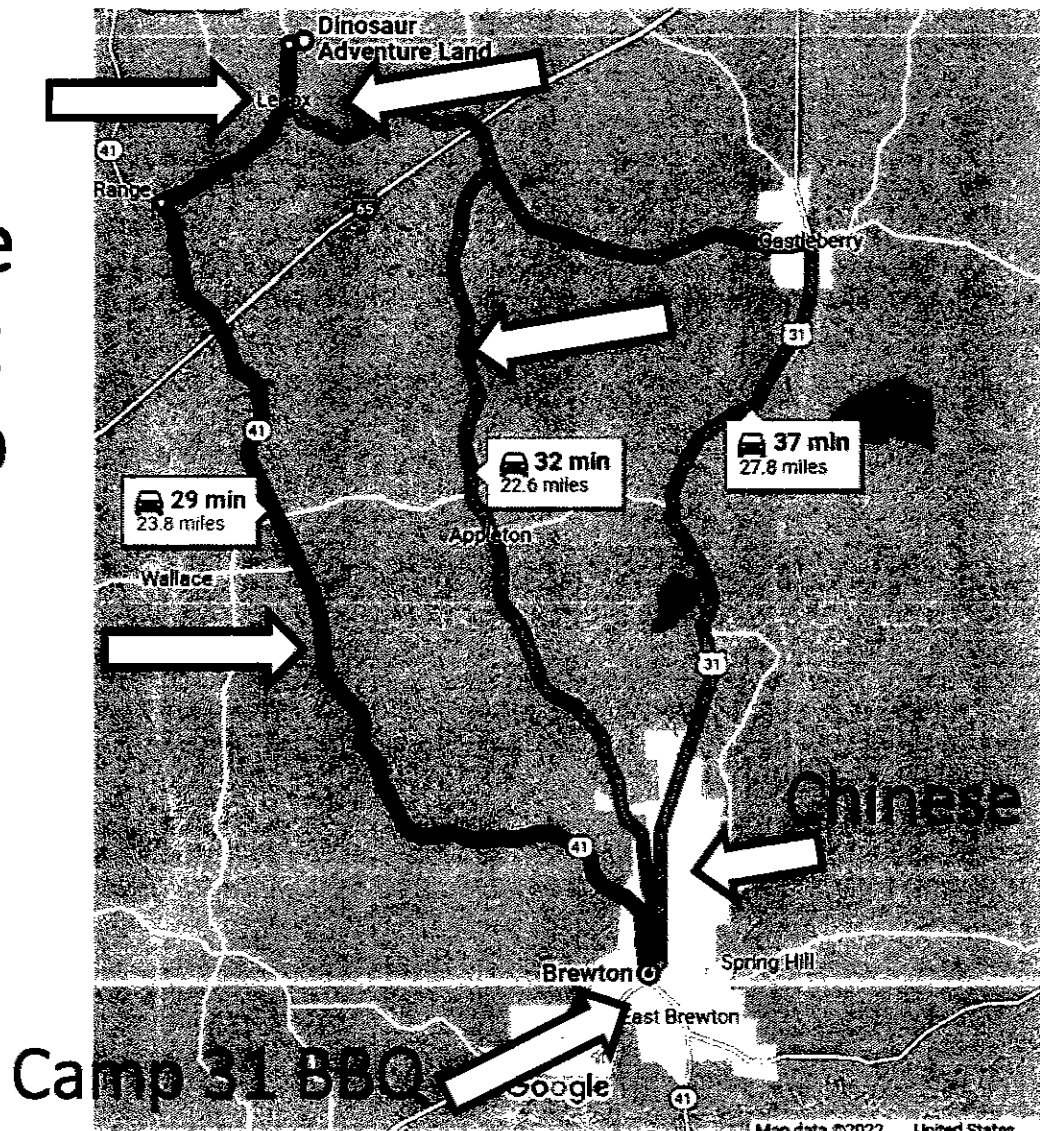

On _____ Cindi asked this court for a PFA from me, Kent Hovind, her former husband. We appeared before this court and I said I was no threat to her or anyone else, but I would be happy to let her get a PFA (DR21-0017) without objection from me and I would certainly stay away from her.

On about July 10, 2022 at about 11:30 a.m. I was taking a group from our Genesis Baptist Church ministry to go eat in Brewton as we have done every Sunday for 4 years. We alternate between going to eat at the Chinese restaurant on the east side of Brewton and Camp 31 BBQ on the west side. See map. Ex. 1

Either way, we must go through downtown Lenox (Ex. 2) and go left or straight at the stop sign by the general store owned by my longtime friend Tom Rigdon 817-240-6182.

For Camp 31 BBQ we go straight at the stop sign in Lenox and go down the blue route.

Either way we must go through downtown Lenox and turn between the general store and the red storage building where she was waiting.



This is a clear case of an angry ex-wife, Cindi Lincoln, attempting to entrap Pastor Kent Hovind who was taking his entire congregation to lunch as they have done for 4 years. Ed. 2d 583 (1972).

Entrapment occurs when an officer or person under his/her control incites, induces, lures, or instigates a person into committing a criminal offense, which that person would not have otherwise committed and had no intention of committing.

Ala. Code 1975, § 13A-3-31

The two tests of entrapment are **subjective entrapment and objective entrapment**. The federal government and the majority of the states recognize the subjective entrapment defense (Connecticut Jury Instruction on Entrapment, 2010). 6.3 Entrapment – Criminal Law

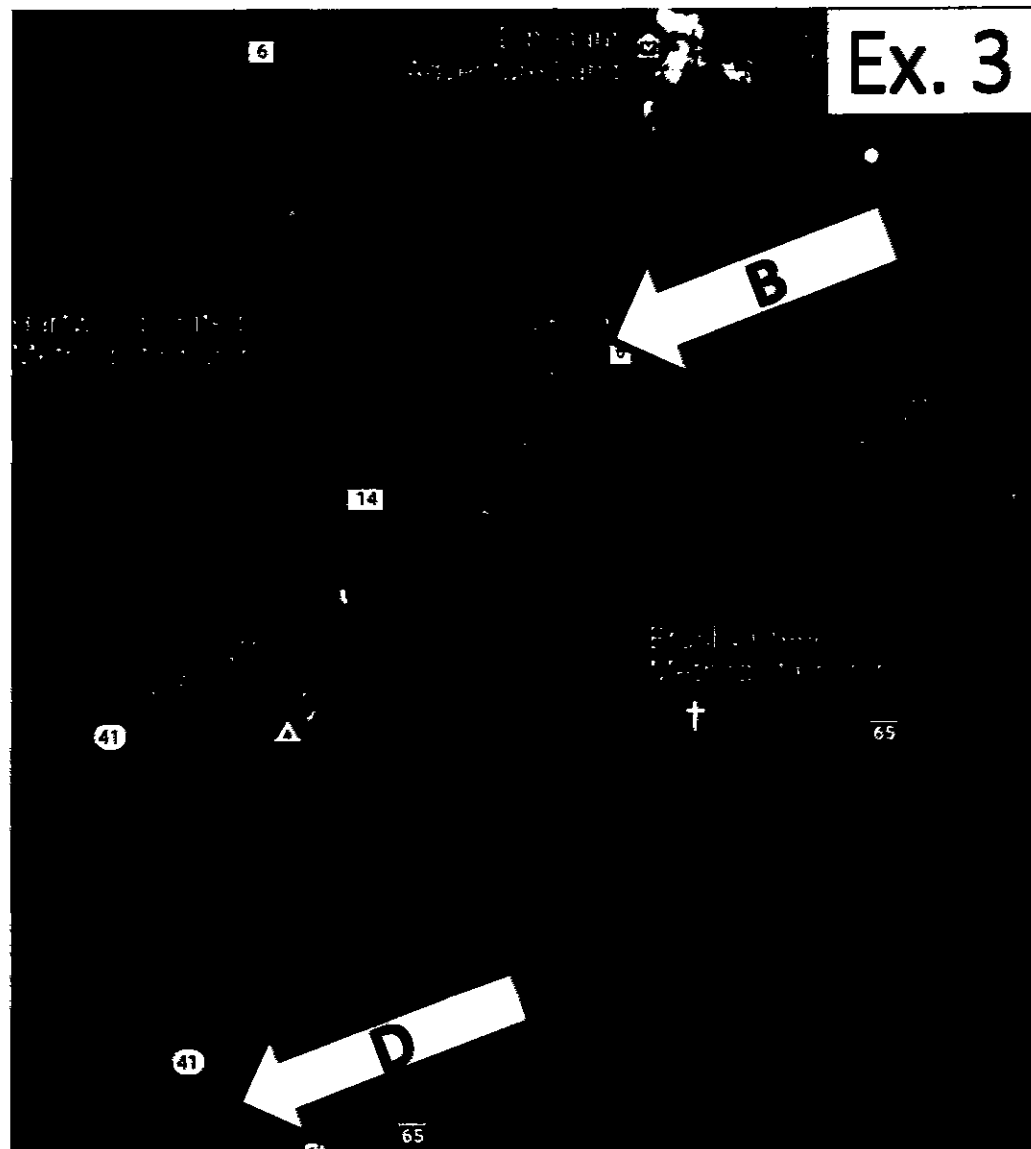
Cindi Lincoln lives about 5 miles away from Lenox on Hwy. 41 at D.

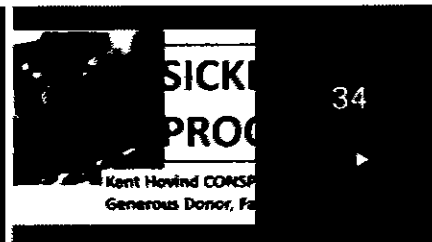

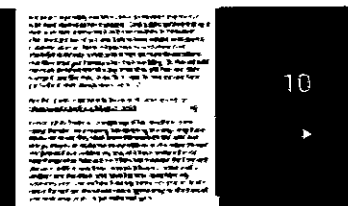

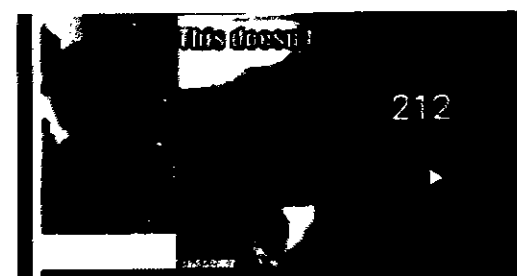

I did not violate the PFA.

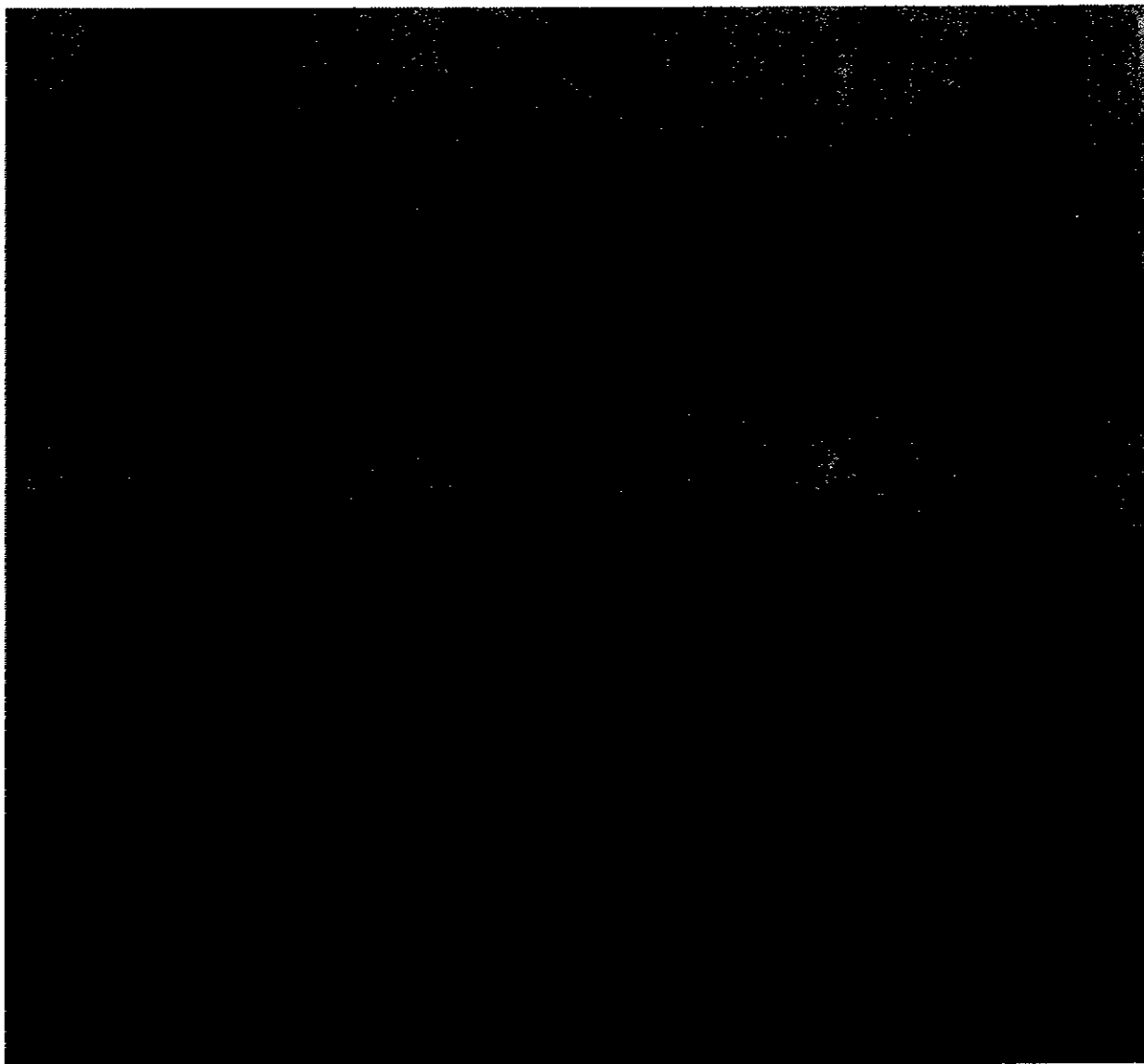

A PFA can be dismissed if it can be shown that the person requesting it has a history of making false accusations. Cindi Lincoln has such a history.

Cindi knows Kent's schedule. On Sundays Kent invites all those who attended his morning Youtube program to go to Brewton to eat. They must go through Lennox to get to Brewton. It is his normal routine and only way to get to Brewton. In traveling on this road, Kent must stop at a 4 way stop sign and travel down a road that is less than 10 feet away from a house that Cindi has been visiting at the same time she knows Kent will be passing by. She knows the exact time he will be passing by, and she has made it a point to be there exactly when she knows Kent will be passing by. On one such occasion Kent saw a group of people outside the little building at this exact 4way stop, waved as normal, was about to pull in to be his friendly self, as he always stops when his neighbors are out...yet, at the last moment, he saw that Cindi was amongst the group and quickly swerved away from the group, getting back onto the road to avoid her. This little building is in the yard of the stop signs (4way) As he was back on the road driving, and due to just getting thru the 4 way stop and trying to get away, John, his neighbor was outside... John proceeded to discuss the price of the store, should Kent be interested. Kent knew he must go and quickly (without being rude) told John he must go and abruptly proceeded to take all his guests to the restaurant.


Later on that week, Kent received a notice in the mail, that he["violated"]his order to stay away from Cindi, despite the fact, she has made it a point to be in the same locations she knows he will be, on a 3 different occasions.

The next time Kent was passing by and saw John outside, he told John that he received a notice of failure to stay away from Cindi... John told Kent, that Cindi had made a comment that Kent "swerved away" because of his order to stay away.

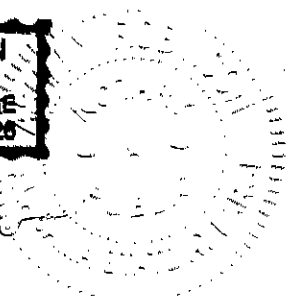
Another Sunday, Cindi parked right next to the Dino Van and came into the same restaurant the DAL group was eating, and sat right next to the cash register, making it impossible for Kent to stay 500 ft away, and then she proceeded to call him Pinocchio as he walked by.

Sept 2021, 9 months after Kent Hovind and Cindi Lincoln separated, she took Kent to court with claims of abuse and asked the judge to issue an order to keep Kent away from her, and because Kent wants her to stay away, wants nothing to do with her, and has done his best to avoid her, he told the judge to please allow her to have the order of protection and it was granted without Kent's full understanding of the long-term repercussions, yet it is Cindi who continues to try to find ways to get close to him, only to harass and corner him. Kent honored her request to stay away in hopes that she would leave him alone and stay away, and now he sees how once again, she is doing her best to make him look bad, when it is her that is obsessed with trying to destroy him, and this is yet, another one of her attempts.
